

Legend Oaks Golf Club Rules and Regulations

Our goal at Legend Oaks Golf Club is to provide a fun, safe, and enjoyable environment for all members and guests. We welcome players of all skill levels and ask that everyone follow these rules to help preserve the course and ensure an exceptional experience for everyone.

Golf Course Rules

Tee Times

Always book your tee time in advance. Arrive early to ensure you're ready to play on time. All members and guests are expected to have at least one person from their group check in with the Pro Shop before beginning play.

Dress Code

Proper golf attire is required on the golf course and practice facilities. Acceptable attire includes collared shirts, golf or athletic shoes, and appropriate golf apparel. Prohibited attire includes jeans, T-shirts, tank tops, cut-off shorts, and inappropriate footwear. Legend Oaks Golf LLC reserves the right to deny access to the golf course, practice facilities, or clubhouse to anyone not complying with the dress code.

Respect the Course

Repair all divots, ball marks, and bunkers after use. Help keep the course in excellent condition for everyone.

Pace of Play

Maintain a reasonable pace of play. A typical round should take approximately four hours. Be ready to play when it is your turn and allow faster groups to play through whenever appropriate. Groups failing to maintain pace of play may be instructed to skip holes, allow groups to play through, or leave the course at the discretion of golf staff.

Ready Golf

Keep your pre-shot routine brief and play when it is safe to do so, even if you are not technically away.

Safety First

Always be aware of other players before hitting. Never hit when another group or maintenance staff is within range. Do not hit shots into or near the maintenance crew. Failure to comply may result in immediate removal from the property.

Course Boundaries

Observe all out-of-bounds markers and course signage. Players may enter residential yards to retrieve golf balls at your own risk.

Lost Balls

Players may search for a lost golf ball for no more than three (3) minutes. If necessary, play a provisional ball to maintain pace of play.

Golf Ball Responsibility

Players are solely responsible for any injury, property damage, or other loss resulting from golf balls they strike. Any damage caused by a player's golf ball is the responsibility of that player. Legend Oaks Golf LLC assumes no responsibility for damage caused by a player's actions.

Golf Cart Etiquette

Stay on cart paths where available and follow all posted cart restrictions. Follow GPS instructions and the posted 90-degree rule when applicable.

Golf Cart Responsibility

The individual renting or operating a golf cart is financially responsible for any damage caused to the golf cart while it is in their possession, regardless of who was operating the cart at the time of the incident. The member or paying patron accepting the cart assumes responsibility for ensuring it is operated safely and returned in the same condition, excluding normal wear and tear. Legend Oaks Golf LLC reserves the right to charge the member account or payment method on file for repair or replacement costs resulting from negligence, misuse, or reckless operation.

Golf carts may only be operated by licensed drivers.

Golf carts shall be always operated in a safe and responsible manner. Reckless driving, excessive speed, horseplay, towing, overloading, or operating a cart while impaired is strictly prohibited. Violations may result in removal from the property without refund and financial responsibility for any resulting damages.

Golf carts are equipped with GPS technology to assist with pace of play, safety, and enforcement of course restrictions. By operating a golf cart at Legend Oaks Golf Club, members and guests acknowledge and consent to the use of this technology while on club property.

Golf Cart Restrictions

Golf carts are prohibited on greens and tee boxes. Stay at least 30 yards away from greens and tees. Follow all GPS warnings regarding restricted areas.

Golf Etiquette on the Green

Avoid damaging the putting surface with clubs or shoes and repair all pitch marks.

Lost or Damaged Clubs

Please return any found clubs to the Pro Shop or Cart Attendant. Legend Oaks Golf LLC is not responsible for lost, stolen, or damaged personal property.

Damage to Club Property

Any individual who damages club property, including but not limited to golf carts, buildings, fences, signs, irrigation equipment, course fixtures, furniture, landscaping, or other club assets, is financially responsible for the cost of repair or replacement.

Wildlife

Respect all wildlife on the golf course. Do not feed, disturb, or interfere with animals.

Children on the Golf Course

Children under the age of 16 must remain under the direct supervision of a responsible adult while on the golf course unless participating in a supervised club program.

Weather

Play is at the golfer's own discretion except when the golf course is officially closed. Players are responsible for monitoring weather conditions. When lightning is detected or club staff suspend play, all golfers must immediately leave the golf course.

Assumption of Risk

Golf is an outdoor recreational activity involving inherent risks, including but not limited to errant golf balls, uneven terrain, weather conditions, golf carts, interactions with other players, and other conditions commonly associated with the game. By entering Legend Oaks Golf Club property or participating in club activities, all members and guests voluntarily assume these inherent risks.

Photography and Media

By entering Legend Oaks Golf Club property or participating in club activities, events, tournaments, or programs, members and guests acknowledge that photographs and video recordings may be taken by Legend Oaks Golf LLC or its representatives for promotional, marketing, advertising, social media, website, newsletter, and other club-related purposes. By remaining on the property, members and guests grant Legend Oaks Golf LLC permission to use their likeness without compensation or further notice. Anyone who does not wish to be photographed should notify club management in advance, and reasonable efforts will be made to accommodate the request.

Smoking

Smoking of cigars, cigarettes, and vape pens is permitted on the golf course and practice areas. Smoking on the clubhouse deck is permitted only away from the dining area.

Pets

Pets are not permitted on the golf course, practice facilities, or inside any club buildings. Leashed pets are permitted on the Bistro patio only. Service animals are permitted in accordance with applicable law.

Bistro Rules

Guests in the Bistro

Legend Oaks Golf LLC reserves the right to add a 20% gratuity to any tab not closed by the end of the evening.

Outside food or beverages are not permitted in the Bistro or anywhere on the golf course.

Children age 15 and younger must be accompanied by a parent or legal guardian while dining in the Bistro.

Legend Oaks Golf LLC reserves the right to refuse alcohol service to any visibly intoxicated individual and may remove any person whose behavior creates an unsafe or disruptive environment.

Proper attire is always required while inside the clubhouse. Members and guests must wear shoes, a shirt, and appropriate pants, shorts, or skirts. Swimsuits may not be worn inside the clubhouse unless they are covered by appropriate attire.

Membership Rules

Member Account Charges

Club members are required to maintain a credit or debit card on file. Members may pay by automatic card payment, manual card payment, cash, or check. Monthly statements will be emailed on the first of each month. Members enrolled in Auto Pay will be charged on the third of each month.

Legend Oaks Golf LLC reserves the right to charge the card on file after three months of non-payment.

Legend Oaks Golf LLC reserves the right to suspend membership due to non-payment or violations of these Rules and Regulations.

Delinquent Account Policy

- **Past Due Balance of \$500:** A reminder notice will be sent to the member, along with information regarding available payment plan options.
- **Past Due Balance of \$1,000:** Member charging privileges will be suspended. No additional charges may be placed on the member account until the outstanding balance is reduced below this threshold.
- **Past Due Balance of \$1,500:** The membership will be placed on hold until the account has been brought back into good standing (\$0). While on hold, all membership privileges, including access to club facilities and participation in member activities, will be suspended.

Family Member Charges

Authorized family members may charge purchases to the member's account. Family members age 15 and younger must be accompanied by a parent or legal guardian while dining in the Bistro.

Medical Leave

Members requesting a medical leave may place their membership on hold for a maximum of three (3) months. Written notice and medical documentation must be submitted at least thirty (30) days prior to the requested leave to activities@legendoaksgolf.com.

Resignation of Membership

Members wishing to resign their membership must provide thirty (30) days written notice. Membership dues remain the responsibility of the member during the thirty-day notice period. Membership initiation fees are non-refundable.

Membership Terms

Club Memberships are Non-Equity

Club membership at Legend Oaks Golf Club is not an investment in the Club or its facilities and does not provide members with any ownership, equity, or property interest. Membership grants a non-exclusive, revocable license to use club facilities according to the membership classification and these Rules and Regulations.

Modification and Termination of Membership Plan

Legend Oaks Golf LLC reserves the right to amend or modify this Membership Plan and these Rules and Regulations at any time. The Club further reserves the right to suspend, revoke, or terminate any membership, with or without cause, at its sole discretion.

Should the Club terminate a membership without cause, one hundred percent (100%) of the actual initiation fee paid within the preceding twenty-four (24) months will be refunded without interest. Following termination, all membership privileges immediately cease.

Enforcement

Legend Oaks Golf LLC reserves the right to refuse service, revoke playing privileges, remove any individual from the property, or suspend or terminate membership for violations of these Rules and Regulations, unsafe behavior, abuse of staff, destruction of property, or conduct deemed detrimental to the operation of the Club.

Failure to comply with these Rules and Regulations may result in removal from the property without refund.
